1. All examinations/practicals scheduled upto 31st March, 2020 are postponed till further orders.
2. All evaluation and related activities scheduled up to 31st March, 2020 are also postponed till further orders.
3. All teaching staff at all levels shall not attend the respective educational institutions till 31st March, 2020 and are advised to stay at home. Only staff or Teacher/Headmasters/Principals assigned administrative work shall attend office and shall also comply with the general instructions issued by the Health & Family Welfare Department, Government of HP.

Teaching staff, including who have been ordered to not to come to the institutions and have been advised to stay at home, will make themselves available to the respective District Magistrates in case they are ordered to do so.




